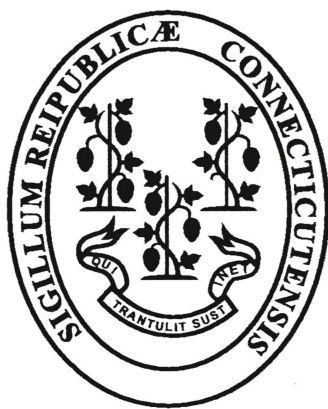

Pursuant to the Laws of the United States

I, Stephanie Thomas, Secretary of the State of the State of Connecticut, do hereby certify that the returns of votes cast for Electors of President and Vice President of the United States of America, for the State of Connecticut, at an election held therein for that purpose, on the Tuesday after the first Monday in November, in the year of our Lord two thousand and twenty-four agreeably to the provisions of the laws of the said State, and in conformity with the Constitution and laws of the United States, for the purpose of giving in their votes for President and Vice President of the United States, for the respective terms prescribed by the Constitution of the United States, to begin on the twentieth day of January in the year of our Lord two thousand and twenty-five, were, on the last Wednesday of November, being the twenty-seventh day of November A.D. two thousand and twenty-four, canvassed by the persons authorized by law to canvass said votes and the list of persons voted for and the number of votes cast for each, respectively, is as follows:

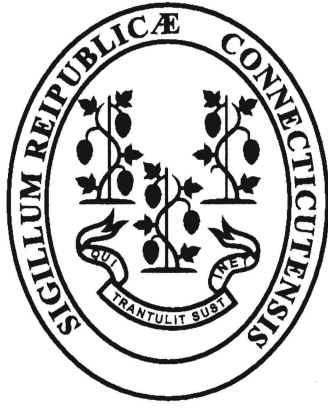
