We further certify that the four Republican Party Electors associated with the Trump-Vance ticket and the one Democratic Party Elector associated with the Harris-Walz ticket will serve as presidential electors unless a vacancy occurs in the office of presidential elector before the end of the meeting at which the

presidential electors cast their votes, in which case a substitute presidential elector will fill the vacancy. If a substitute presidential elector is appointed to fill a vacancy, we will submit an amended certificate of ascertainment stating the names on the final list of this state's presidential electors.
